At tonight's meeting, I raised the issue of checks with unredacted bank account numbers being improperly included in the public agenda. You replied that the account numbers were redacted. This is simply untrue. I have attached a screenshot of one set of checks and a link to the the other set of checks that were included in today's meeting agenda that you (and staff) uploaded onto the Tabernacle Township website. As you and committee will see, there are no redactions whatsoever. All identifying numbers on the checks are fully visible. Please assure that private financial information is not disclosed, as required by OPRA. Please also assure that the minutes of tonight's meeting do not include the false statement that the township redacted any information because the checks show that you did not.

Regarding closed session minutes, I see that you are now commingling regular meeting minutes and closed session minutes on the township website in the agenda/minutes page titled "Minutes." As a reminder, a closed session meeting was held on April 25, 2022. However, these minutes are not listed in the Minutes section but are contained in the April 25, 2022 regular meeting minutes. Citizens should not have to hunt for these closed session minutes. They should be readily accessible.
